



Kneehill County 75th Anniversary Photo Contest Official Rules

Who Can Enter

1. To be eligible to participate in this contest, entrants must be residents of Kneehill County (including hamlets), Acme, Carbon, Linden, Three Hills or Trochu.
2. Employees of Kneehill County are ineligible.

How to Enter

- a) To enter, log onto www.kneehillcounty.com, fill out the Photo Contest Submission Form and upload your submission photo. The photo must be in digital format, less than 2 MB in size and taken within Kneehill County. When submitting, keep in mind the contest theme: ***Kneehill County: Celebrating 75 Years of Rural Living***
- b) By entering, entrants represent and warrant: (i) that they own the picture submitted, and (ii) it does not violate the rights of any third parties. No lewd, nude, crude, or offensive photographs (as determined by Kneehill County in its sole and absolute discretion) will be accepted. Kneehill County reserves the right in its sole and absolute discretion to disqualify any entry.
- c) If submitting a photo in which a person is recognizable, entrants must receive the subject's explicit permission/release for use, or in the case of a minor, the subject's parent/guardian's permission for use, and provide it to Kneehill County upon request.
- d) The contest starts on March 18, 2019 and all entries must be received by Kneehill County by July 31, 2019 at 4:30 pm MST. Kneehill County is not responsible for lost, late, or misdirected entries, printing errors, server unavailability, computer, or any other electronic malfunction.
- e) All valid entries will be judged by a Panel Jury. Photos that best represent the contest theme ***Kneehill County: Celebrating 75 Years of Rural Living*** will be selected, at the sole and absolute discretion of the Panel Jury.

The Prize(s)

1. One (1) First Place Winner, one (1) Second Place Winner and one (1) Third Place Winner will be selected from the photo submissions. The First Place Winner will receive an Apple Ipad Mini, the Second Place Winner will receive a Bose Wireless Speaker, and the Third Place Winner will receive an Amazon Echo.
2. Each winner will be notified via the contact information they provided on the Photo Contest Submission Form. Before claiming the prize, the winner must provide his/her correct name, address and telephone number to Kneehill County at the time of notification. Each winner must sign and return a release and affidavit of eligibility, which must be received within fourteen (14) days of

notification, at the time each winner claims his/her prize in person at Kneehill County. If a winner is a minor, then the winner's parents or guardian must sign a release and affidavit of eligibility before the winner receives his or her prize. Each winner must show picture identification to claim prizes. Kneehill County reserves the right to examine additional identification and may choose to accept or deny awarding the prize based on the identification presented.

3. If a winner cannot be notified within fourteen (14) days, or does not timely sign and return the release and affidavit of eligibility, then the prize will be forfeited, and the prize will be awarded to an alternate winner selected from among remaining valid entries.
4. There will be no substitutions or cash alternatives for any prize except at the sole discretion of Kneehill County. Kneehill County has the right to substitute a prize of similar value. No transfer or assignment of prizes is allowed.
5. Only one prize will be awarded per household.
6. Kneehill County is not responsible for any liability arising directly or indirectly from the award or use of the prize.
7. In claiming your prize, you acknowledge that Kneehill County has the right to publicize your name, character, likeness, photograph, voice and the fact that you are the winner for promotional purposes without financial remuneration.
8. In order to claim your prize, you must also sign a release form granting Kneehill County permission to use/reproduce your image for promotional, digital and other materials.
